Salient features of the Quality Control Order once effective -

- 1. The goods mentioned must conform to the corresponding Indian Standard specified.
- 2. The goods mentioned must bear the Standard Mark under a license from the Bureau of Indian Standards.
- 3. The Bureau of Indian Standards shall be the certifying and enforcing authority in respect of the goods or articles specified.
- 4. The order shall not apply to articles meant for export.
- 5. Failure to comply shall attract the penalty applicable under the Bureau of Indian Standards, Act 2016.
